REGULAR MEETING MINUTES

CITY COUNCIL MEETING: 5:06 p.m.

MEETING CALLED TO ORDER: Mayor, Steve Corr called the meeting to order at 5:06 P.M.

MINUTES: Bill Abbott moved and Mike Yenney seconded to approve the minutes from the meeting on August 26, 2020. Motion passed.

ACCOUNTS PAYABLE: A motion was made by Bill Abbott and it was seconded by Cindy Gray that the city pays the bills presented for September 2020. Motion passed.

MAINTENANCE REPORT: request submitted to purchase a thumb for the backhoe. The council decided to table this until a later date because it isn't budgeted for. No action was taken.

FOREST MANAGEMENT REPORT: Bids for PCT (pre-commercial thinning) came in. The forester and clerk will check to make certain that this has already been approved by the council. The forester said the bid seemed reasonable.

POLICE REPORT: Sheriff Richie Skiles was present to discuss any needs or concerns the city may have. He volunteered to assist the city in hiring a code enforcement officer and also in working on the animal ordinance.

AGENDA:

- **Draft of Changes to Animal Ordinance**—the draft ordinance for animals was discussed. It was moved by Bill Abbott and seconded by Mike Yenney to have the LCSO review the draft with the City Attorney and to make recommendations for an enforceable ordinance to control a nuisance by animals within the city limits. Motion passed.
- **ADA Proclamation**—it was moved by Bill Abbott and seconded by Mike Yenney to affirm the Proclamation of Recommitment to Full Implementation of the Americans with Disabilities Act (ADA) with the date of September 9, 2020. Motion passed.
- **Water Project**—Mike Woodworth reported that the project is out for bid. Potential bidders are invited and encouraged to attend a walk through of the project at 1:00 p.m. on Wednesday, September 23, 2020. The bid opening will take place on Wednesday, September 30, 2020. No action was taken.
- **Wastewater Project**—no report
- **6th Street Bridge Project**—no report.
- **Code Enforcement Officer**—the city discussed hiring a Code Enforcement Officer and to partner with Deary. At this point the city is considering 10 hours per month. It was moved by Mike Yenney and seconded by Bill Abbott to collaborate with Deary in hiring a Code Enforcement Officer for 10 hours a month. The city would prefer an independent contractor. Motion passed.
- **COVID-19**—no discussion or action was taken at this time.
- **Executive Session**—No Executive Session was held.

Additional Business: Susan Wilson reported that she would like to have the comp plan on the next agenda and get the public hearings set for October for finalization of the plan.
